About the ACA

Before completing this section of the form, please read the information set out below on the Australian Cricket Players Limited Constitution which is available in full at <https://www.auscricket.com.au>.

The ACA is a public company limited by guarantee, registered under the *Corporations Act 2001* (Cth) (Corporations Act).

- A public company limited by guarantee is required to comply with the applicable provisions of the Corporations Act and is formed on the principle that the liability of members is limited to the amount they agree to contribute if the company is wound up.
- Clause 2 of the ACA's Constitution stipulates that if the ACA is wound up, the amount each member, or each person who was a member during the year ending on the day of the commencement of the winding up of the ACA, will be liable to contribute is limited to \$1.00 (Member's Guarantee Amount).
- Clause 40 of the Constitution stipulates that, among other things, each member authorises the ACA to enter into Cricket Collective Agreements (as that term is defined in the Constitution) for and on behalf of that member, and that upon becoming a member, each member approves any Cricket Collective Agreements which are already in place.
- Clause 41 sets out that each member irrevocably:
 - a) Grants the ACA the legally binding authority to approve the use by CA, State Associations, Territory Associations and/or W/BBL Teams, or their licensees, of their Attributes in any trading cards, electronic or digital games or Team-Based Licensed Products on the basis that they shall be entitled to receive payments in accordance with the MOU for any such use of their Attributes in any Team-Based Licensed Products but not entitled to receive payments for the use of their Attributes in trading cards or in connection with electronic or digital games;
 - b) Grants the ACA the legally binding authority to enter into any Cricket Collective Agreement which may allow CA, a State Association, a Territory Association and/or W/BBL Teams, or their licensees to use their Attributes where they are a Surrounding Player in a Surrounding Player Licensed Product (that is, where the Member is a player surrounding the featured player(s) in a player-based CA or CA-licensed product) without being entitled to receive any payments under the terms of such Cricket Collective Agreement for such use; and
 - c) Provides a legally binding approval of any Cricket Collective Agreements which are already on foot at the commencement of their membership.
- Clause 42 of the Constitution sets out that each member authorises the ACA to, among other things, receive, collect and use information for the member's benefit (including notices and copies of contracts), which may include Personal Information of the Member, relating to any actual, alleged or potential breach by the member (or a class of persons which the member forms part) of any code of conduct or behaviour, playing condition, rule, guideline, policy and/or contract with a third party as well as analyse and/or provide advice to the member regarding an alleged breach, penalty or sanction.
