About the ACA

The ACA is a public company limited by guarantee, registered under the *Corporations Act 2001* (Cth) (Corporations Act).

- A public company limited by guarantee is required to comply with the applicable provisions of the Corporations Act and is formed on the principle that the liability of members is limited to the amount they agree to contribute if the company is wound up.
- Clause 2 of the ACA's Constitution stipulates that the amount each member, or person who was a member during the year ending on the day of the commencement of the winding up of the ACA is limited to \$1.00 (Member's Guarantee Amount).
- Clause 6 of the Constitution requires that in order to be eligible to be a member a person must, among other things, agree to assume the liability to pay the Member's Guarantee Amount, support the objects of the ACA as set out in the constitution and agree to comply with the terms of the Constitution.
- Clause 40 of the Constitution stipulates that, among other things, each member authorises the ACA to enter into Cricket Collective Agreements (as that term is defined in the Constitution) for and on behalf of that member, and that upon becoming a member, each member approves any Cricket Collective Agreements which are already in place.
- Clause 41 of the Constitution sets out the terms on which each member (including both current players past player members) irrevocably grants the ACA the legally binding authority to approve the use of their Attributes (as that term is defined in the Constitution) by CA, a State Association, a Territory Association, and/or a W/BBL Team or their licensees.
